1 BACKGROUND INFORMATION

1.1 Country overview

Mauritius is a multiparty parliamentary democracy and an island state of about 1.3 million people. The country's economy has made great strides since independence in 1968 and is now classified as a high-income country.

The country's gross domestic product (GDP) in 2019 grew 3.6%, driven by construction and services sectors (banking, ICT) as well as a rebound in agriculture. Manufacturing growth remained on a sluggish trend and was negatively impacted by decelerating global demand during 2019. Based on its 2019 data, Mauritius was classified as a high-income country by the World Bank for the first time in July 2020.

The COVID-19 pandemic is severely affecting the country's economy through a standstill in tourist arrivals, and crumbling export demand in particular for its garment sector. The government put in place a support package to help the private sector cope with the shock, which mitigated the impact on employment, while in combination with declining revenue leading to a large deficit for the fiscal year 2019/20.

The human development index (HDI) of Mauritius, which is the index used by the United Nations to measure the progress of a country, was 0.804 points in 2019, leaving it in 66th place in the table of 189 countries published.

Mauritius faces the challenge of managing its transition to a knowledge-based economy, driven by innovation and productivity growth. This will require a concerted effort to remove bottlenecks to new sources of growth and private investment, such as a lack of connectivity, skills shortages, and misaligned incentives that will also be critical for its recovery from the COVID-19 induced recession.

While the trend may have recently been reversed, inequality has been on the rise for a number of years. Public transfers have contributed to mitigate the rise in total income inequality. While general unemployment was low pre-COVID-19 (6.9% in Q1 2020), women face a higher unemployment rate at 9.8%, and a much lower labour force participation rate.

1.2 Sector situation

In the early 1940s in Mauritius, there was an epidemic of poliomyelitis, which awakened the consciousness of civil society towards person with disabilities. Hundreds of children were affected and those who survived became disabled. At that time, social workers and charitable institutions started to take actions for improving the living conditions of disabled persons. Gradually after the independence of Mauritius, parastatal bodies and NGOs started to provide specialized care, education and training to disabled children, adolescents and adults. Throughout the 1980s and 1990s, government has been active in bringing legislative measures to accelerate the process of social integration of persons with disabilities into the mainstream society.

Currently, there are more than 70 NGOs providing services to persons with disabilities. Special agencies falling under the ministry of social integration also provide services to persons with disabilities:

- the Disability Empowerment Unit, which is the department of the ministry that provides a customer care service to persons with disabilities
- the National Council for the rehabilitation of disabled persons, which coordinates the work of NGOs that cater for the welfare of disabled people, and promote the welfare of people with disabilities
- the Training and Employment of Persons with Disabilities Bureau, which main objectives are to prevent discrimination against disabled people resulting from their disability, and to facilitate their training and employment
- the Lois Lagesse Trust Fund, which goal is to educate and train blind persons
- and the Society for the Welfare of the Deaf

In the state of Mauritius, both government and civil society have enormously contributed to the integration of people with disabilities in the mainstream society. Compared with the 1960s, nowadays the policy in favour of persons with disabilities has moved from the charity model

towards the human rights model. The policy goals of the ministry have changed and include building an inclusive: a society where persons with disabilities are valued as equal to other people, where their skills, talents and potential are recognized and valued, where their rights are respected, where restrictive barriers are removed in terms of access to services and employment, and where disability is considered as an intrinsic part of human diversity and where discrimination on the basis of impairment is prohibited.

1.3 Role of partner institution in the sector

The objective of the Ministry of Social Integration, Social Security and National Solidarity is to support national development for an inclusive society. Its missions are to promote and enhance social protection and national solidarity, empower and protect persons with disabilities elderly persons and local communities to enhance their quality of life and promote capacity building for NGOs.

The disability empowerment unit is responsible for the conceptualization and implementation of disability policies projects and programmes and facilitates the process of integration of persons with disabilities in the mainstream society. It also coordinates matters relating to the United Nations Convention on the Rights of Persons with Disabilities, which Mauritius has signed in 2007 and ratified in 2010. The unit also provides a series of direct services to persons with disabilities and to non-governmental institutions.

With a view to assisting persons with disabilities in their daily lives, the Ministry provides the basic invalidity pensions (BIP) to persons with disabilities satisfying the eligibility criteria. They also receive other types of social benefits provided by the ministry.

2 ACTION DESCRIPTION

2.1 Overall objective

Access to employment and social protection is expanded to poor and vulnerable groups

2.2 Specific objective (s) (purpose)

- SO1: To facilitate the design and delivery of effective services as per the aspiration of persons with disabilities
- SO2: To facilitate the development of the future Disability Bill and the 2021-25 Action Plan for the disability sector

2.3 Expected results

An overall assessment report of disability sector (including actors, governance mechanisms, services, legislation, policies and compliance with the UNCRPD) in Mauritius is drafted

2.4 Final deliverables

- D1: A report on the legislation concerning persons with disabilities in Mauritius
- D2: A report on the services provided to persons with disabilities in Mauritius
- D3: A report on the governance of the disability sector in Mauritius
- D4: An overall assessment report on legislation, services, and governance of the disability sector in Mauritius

3 METHODOLOGY

3.1 General methodology (of the action)

The technical assistance provided by SOCIEUX+ through mobilized EU public experts shall unfold in four stages. While the first activity has been performed at distance (because of COVID-related travel restrictions), the three remaining activities are to be performed on-site.

The first activity allows experts and the partner to jointly outline a mapping of the existing legislation in favour of persons with disabilities in Mauritius; a particular attention is paid to assess the compliance of the relevant national legislation with the UNCRPD, and to eventually identify areas where the State of Mauritius does not yet comply with it.

During the second activity, experts assess the current system of social protection services and benefits to which persons with disabilities are entitled. The assessment particularly addresses the levels of adequacy, extent (coverage), and design of disability-inclusive social protection policies and services that are currently implemented in Mauritius. To this purpose, expert work in two directions: they map and appraise the system of measures, programs, entitlements that are provided by the Government and public thematic agencies, and gather the point of view of persons of disabilities and their representative organizations. The compliance with the UNCRPD is considered by experts throughout their analysis. Experts pay a particular attention to identifying eventual gaps in coverage of socio-economic groups of persons with disabilities, and therefore consider possible issues related to targeting, assessment, and enrolment in social protection schemes, of people with disabilities.

The **third activity** serves the purpose of analysing the structures of governance and administration that uphold the disability-related system of social protection. Experts observe both the formal governance and administrative structures (institutional responsibilities, decision-making process, monitoring and evaluation of policies and programs, ...) and the organizational (procedures, work-flows, data management, coordination structures ...) and individual capacities available to the system of social protection for persons with disabilities. A particular attention is paid to the relation between public and private entities, including the role of non-governmental organisations.

The fourth activity allows to wrap up the conclusions and recommendations of the three previous missions and draft the final sector assessment. The final deliverable results not only from a consolidation of the reports developed through the previous activities, but provides final systemic conclusions and ensures an overall coherence of the sectorial assessments. During the last activity, experts present the results of the overall assessment to the executives and staff of the Ministry of Social Integration, Social Security and National Solidarity, and to other stakeholders eventually identified by the Ministry.

3.2 Planned activities (work plan of the action)

The following activities are currently planned for the action:

- Activity 1 - Assessment of the legislation concerning persons with disabilities (at distance)
- Activity 2 - Assessment of the services provided to persons with disabilities (on site)
- Activity 3 - Assessment of the governance of the disability sector (on site)
- Activity 4 - Finalisation of the overall assessment report and presentation to the partner institution (on site)

The present terms of reference cover the services expected for activities of the above work plan:

- Activity 3.

3.3 Inclusion of cross-cutting issues

SOCIEUX+ recognises the importance to include cross-cutting issues in social protection, labour and employment policies and systems. The following cross-cutting issues are duly taken into account:

- Gender equality;
- Good governance;
- Human rights (including rights of children, people living with disabilities, vulnerable groups and minorities); and,
- Social and economic inclusion of vulnerable groups.

4 ACTIVITIES DESCRIPTION

Activity 3: Assessment of the governance of the disability sector

4.1 Tasks

Minimum tasks expected from the experts shall include:

- Ahead of the on-site mission, to get substantial knowledge of the local context; review any relevant background documents provided by the SOCIEUX+ Team and/or the Partner.
- Preliminary contacts with the Partner in view of the preparation of the mission's methodology and agenda, to be transmitted ahead of the mission to the SOCIEUX+ team for approval;
- Taking part to the preparatory briefing with SOCIEUX+ team;
- During the activity, to conduct the planned consultations with the Partner's executives and staffs, as well as any other external actor that can support the positive deployment of the mission, including the EU Delegation in the country;
- At the end of the mission, presenting to the partner the outcomes of the peer-to-peer exchange in order to discuss and take into account any comment on the contents of the deliverables before their finalization;
- Timely submission to SOCIEUX+ of the final deliverables (10 working days after the end of the period devoted to the remote cooperation), and availability to go through an eventual round of comments and adjustments in interaction with SOCIEUX+ and the Partner;
- To channel to SOCIEUX+ Communication officer any material that can be useful to inform the public about the activity (pictures, interviews, brief notes or articles).
- To employ the different templates and evaluation forms provided by the SOCIEUX+ Team.

4.2 Deliverables

Pre-mission deliverables (to be transmitted to SOCIEUX+ team at least three working days ahead of the activity)

- P1: A methodological note, detailing the working approach, tools and methods to employ, a risks analysis, etc. The Methodological Note shall not exceed 3 pages (excluding cover page and annexes).
- P2: A activity/mission agenda, detailing the meetings and working sessions to be held, persons to meet, etc. The Activity/mission Agenda shall not exceed 2 pages.

Final deliverables (to be transmitted to SOCIEUX+ team no later than ten days after the activity's completion):

- An individual (or a joint) Expert Mission Report (ExMR) in SOCIEUX+ format (template provided). This report is a confidential product intended solely for and use by SOCIEUX+. (see instructions on the template).
- An individual Expert Feedback Form (ExF), completed online (see instructions and link on the ExMR template).
- A single Activity Report (AcR) in SOCIEUX+ format (template provided). The AcR is intended for the Partner Institution, and will be shared, most probably, with key stakeholders of the action. The report will reflect the tasks conducted in during the activity. It shall provide a meaningful contribution towards the final deliverables of the action.
- D3. A report on the governance of the disability sector in Mauritius.

NB: The principal expert is in charge of leading the mission and is ultimately responsible for the submission to SOCIEUX+ of all deliverables of the activity. He/she will be responsible for the preparation, coordination, implementation and reporting of the overall activity towards SOCIEUX+.

5 REPORTING AND SUBMISSION OF DELIVERABLES

5.1 Formats

All deliverables and products of the activity (notes, reports, presentations, etc) shall comply with the formats and templates provided by the SOCIEUX+ Team.

All deliverables are to be submitted in electronic in electronic editable versions [Microsoft Word 97-2003 [doc], PowerPoint 97-2003 [ppt] and Excel 97-2003 [xls]; or in equivalent OpenDocument format). Non-editable electronic document such as in Portable Document Format (PDF) shall not be accepted.

Templates for electronic presentations during the activity/mission are provided by the SOCIEUX+ Team. These templates are in Microsoft PowerPoint format and comply with the SOCIEUX+ Corporate Image standards. These templates are to be used as a sole format by all members of the expert mission team. They are to be used for all presentations by the experts during and for the activity/mission. The use by the experts of their own, or their organisation(s), templates or formats are not allowed unless otherwise instructed in written [by email] to the experts by the SOCIEUX+ Team.

All versions of deliverables or other products used or produced during activity/mission by the experts shall include the following disclaimer:

All deliverables are to be provided in English.

5.2 Submission and approval

All deliverables versions (drafts, final or other) shall be submitted directly and only to SOCIEUX+ Team, unless otherwise instructed in written [by email] to the experts by the SOCIEUX+ Team.

5.2.1 Pre-mission deliverables

- Pre-mission deliverables shall be submitted no later than 5 working days before the start of activity or departure of the mission of the experts, whichever is the earliest.
- Pre-mission deliverables will be shared and reviewed by the SOCIEUX+ and the Partner Institution. Feedback on the deliverables should be provided to the Principal Expert at latest 2 days before the start of activity or departure of the mission of the experts, whichever is the earliest. Comments and recommendation of this feedback shall be taken into account for the implementation of the activity/mission by the experts. Only the mission agenda shall be resubmitted with revision if requested by the SOCIEUX+ Team.

5.2.2 Final deliverables

- The first draft versions of the final deliverables are to be submitted no later than 10 working days upon completion of the activity or return of the experts.
- Feedback to the first draft version of the report should be provided 10 working days after its submission.
- Inclusion of the feedback on drafts versions is expected 5 working days upon reception of the comments by the principal expert. (In general, no more than one round of feedback and revision is required, unless the quality of the deliverables is considered unsatisfactory by the SOCIEUX+ Team or/and the Partner Institution.)
- Final versions of the deliverables should be approved or rejected no later than 10 working days upon their submission to the SOCIEUX+ Team.
- Final payments and reimbursement of travel costs to experts can only be authorised upon approval of the final version of the deliverables by SOCIEUX+.

7 APPLICATIONS

7.1 Call for experts

All calls for experts for SOCIEUX+ activities are published online on the SOCIEUX+ website. Interested experts should submit their application on the SOCIEUX+ on-line expert database: <https://pmt.socieux.eu> (currently only available in English). The application process is:

1. If they have not already, experts create their SOCIEUX+ account by clicking on "Create an account" using an email address.
2. Login details for their account will be sent to experts by email, experts should create and submit their profile for review by¹:
 - a. Providing contact details
 - b. Providing information on the competences, skills and working history of the expert. Experts are required to provide only limited information through fields marked with an asterisk. However, *experts are encouraged to complete in most detail de sections on skills and competences as the SOCIEUX+ Team also regularly reviews profiles in the roster to identify and contact potential experts for future missions.*
 - c. Uploading of a curriculum vitae, preferably in Europass format².
3. Once their profile is approved by the SOCIEUX+ Team, they can apply to any available calls for experts accessible under the tab "Call for experts" and click on "Apply."

7.2 Selection of experts

In principle, SOCIEUX+ mobilises experts from the public administrations and mandated bodies of EU member states, and practitioners working for social partners, including:

- Practitioners, civil servants and employees from publicly mandated bodies;
- Collaborators and employees of social partner institutions, such as trade unions and employer associations; and,
- Academic and research institutions.

Active public experts from collaborative institutions are given priority in the selection. Private consultants may also apply. Their application will be considered in case an appropriate public expert cannot be identified.

Only short-listed applicants may be contacted. The selection process may include interviews by phone or other communication means.

7.3 Contracting of public experts

Public experts can be in active duty or retired. Retired employees from international specialised agencies or cooperation agencies can also be mobilised, without regard to their former employer's collaborating with SOCIEUX+ on a specific action. Retired experts are considered as public experts for all purposes, benefits, and financial compensation provided by SOCIEUX+.

Short-listed candidates may be required to provide the contact of employer or proof of their ability to be directly contracted under their status as civil servant or public employee.

7.4 Financial compensations

Contract officials or active-duty or retired employees are entitled to standard fixed allowances of 350 euros per working day worked. The fees of private consultants are negotiated according to their number of years of relevant expertise and the standard scale of SOCIEUX+.

Retired experts are assimilated to public employees for all intents and purposes, benefits and financial compensation provided by SOCIEUX+.

National regulations on remuneration and compensation of public employees and civil servants applies, and may limit the payment of allowances by SOCIEUX+. The responsibility for compliance and verification lies with individual experts and their institutions of origin. The payment of income or other taxes is the sole responsibility of the mobilised experts and/or their organisations.

7.5 Travel costs

All travel expenses for the mobilised experts (public, private or international institutions) are covered by SOCIEUX in accordance with the **Guide for Experts and Collaborative institutions** with detailed information on contracting with SOCIEUX+ (version as on date of signature of the contract).

8 COMMUNICATION & VISIBILITY

SOCIEUX + can use its communication channels, such as the web, newsletter and other media, to share information about the implementation and results of the activities. For this, contributions of the experts mobilised are expected. The experts may be requested to provide such contributions in the field of communication as photographs, provide short texts, and interviews.

Short briefings, before and after the mission, with the Communication Officer of SOCIEUX+. This briefings will provide the opportunity to identify communication opportunities and strategies.

For specific activities, visibility products, such as brochures, USB sticks, notebooks and pens, can be made available to experts for on-site distribution.

9 CODE OF CONDUCT

The experts mobilised by SOCIEUX+ will provide technical assistance from the preparatory stages of each activity to the delivery of products. The SOCIEUX+ Team will assist experts to fulfil their assignments by supporting and advising on the preparation of background materials before meetings. The SOCIEUX+ team will collect feedback from partner institutions and relevant stakeholders to ensure that mission reports and recommendations are delivered to national authorities, the EU Delegations in the partner countries and EuropeAid.

The experts mobilised are not representing SOCIEUX+ or the EU. Technical opinions and recommendations expressed are their own. They shall not express negative opinions on the implementation of actions supported by SOCIEUX+ to third-parties. Nevertheless, they shall be aware of SOCIEUX+'s objectives and functioning, and promote its services at the best of their knowledge, whenever possible and feasible.

The experts shall perform their duties in the Partner Country in a way that is fully compliant with and respectful of the local institutions, policies and cultural behaviours. They shall particularly adopt a culturally-sensitive behaviour in their way to deal with the local counterparts.

ABOUT SOCIEUX+

The European Union (EU) promotes and maintains dialogue on social protection and inclusive employment policies with an increasing number of partner countries. This effort has been confirmed by the European Commission (EC) Communication COM (2016) 740 final - "Proposal for a new European Consensus on Development, entitled *Our world, our dignity, our future*. A significant number of cooperation initiatives in these fields are funded by geographic or thematic instruments of the EU in different countries. Those initiatives are highly structured and address the medium- to long-term needs of partner countries.
