

SOCIEUX+ E-LEARNING AWARD - ENGLISH



Aim of the award

As blended learning and self-guided learning present interesting opportunities for [SOCIEUX+](#), an open source [online learning platform](#) has been developed by SOCIEUX+ in 2020. Teams of experts mobilised by SOCIEUX+ can develop courses on this platform for the SOCIEUX+ activities in the field of labour market and employment and social protection. The platform offers great opportunities for capacity development, but it is a challenge to develop good pedagogic content. To give teams of experts extra motivation to make more interesting, pedagogically well-designed and beautiful online courses, SOCIEUX+ organises an e-learning award.

Participants

Only (a team of) experts who worked as experts mobilised by SOCIEUX+ and used the learning management system of SOCIEUX+ during a SOCIEUX+ activity can participate to the e-learning award. Only e-learning developed before the deadline of submission of the proposals (14 April 2023) can be taken into account. E-learning developed within the learning management system of SOCIEUX+ before the award was announced officially can be taken into account. Selection Committee

A selection committee would consist of at least five members. Some members of SOCIEUX+ will participate in the selection committee, as well as at least two external members from international organisations, academia, focal points or the implementing partners of SOCIEUX+. At least one person is fully external to the organisation of the award. The members of the selection committee are selected given their competences in the field. No budget is foreseen to remunerate members of the selection committee. Members of the selection committee should not have a direct or indirect link to participants to the award. In case there is a link they cannot rank this e-learning.

Selection criteria

The members of the selection committee will be asked to quote and rank the e-learning of the experts mobilised by SOCIEUX+ on a set of transparent judging criteria. These criteria are the following:

The course

- Is well suited for the target audience and partner institution (10 points);
- Has clear learning objectives (10 points);
- Considers the state-of-the art of literature and good practices in the field (20 points);
- Stimulates interactivity (10 points);
- Has clear and concise instructions (10 points);
- Has a good didactic plan and assessment strategy (20 points);
- Is designed attractively (20 points);

For the best ranked e-learning, the selection committee will also consider feedback from the partner institutions and participants.

The selection committee will write minutes of its selection meetings that are signed by all members of the selection committee.

Announcement of the existence of the award

The award was announced during the expert seminar on 21 April 2022 organised by knowledge development and will be mentioned on the SOCIEUX+ website (in the news section). The existence of the award is also mentioned during the briefings with experts mobilised by SOCIEUX+.

Announcement of winners of the award

During a webinar organised by SOCIEUX+ (e.g. on e-learning) in Spring 2023, SOCIEUX+ will organise a small ceremony to honour the winners of the award.

Award

For the three highest ranked courses there will be an in-kind prize. The first prize would be the participation in the [d-teach and ITC ILO e-learning design lab](#) or a similar course. The second prize would be participation into an advanced Moodle course (e.g. [Moodle educator certification programme](#)) or a course about the visualisation of ideas. The third prize would be a book on designing e-learning. A monetary prize is not foreseen in the budget. Prizes may not be granted, in part or in full, if the contracting authority does not deem the proposals satisfactory.

Data privacy

Communication and exchanging and storing information will be done in a way that guarantees that the integrity and confidentiality of the data sent by the participants is maintained.

Intellectual property

The rules of intellectual property of SOCIEUX+ apply, as stipulated in the contract among SOCIEUX+ and the experts.
