1. Background information

1.1. Country Overview

Uzbekistan is a landlocked country located in Central Asia that borders the countries of Afghanistan, Kazakhstan, Kyrgyzstan, Tajikistan, and Turkmenistan. It is the most populated country in Central Asia, 35 million people. Its capital and largest city is Tashkent (almost 2,7 million people). Other big cities are Namangan (almost 0,6 million people) and Samarkand (0,53 million people). The distribution between urban and rural population is 50/50.

Uzbekistan is a post-soviet country. It was governed by the first president Islam Karimov till his death in 2016. After the transition of power in 2016-2017, some liberalization reforms were conducted, and modernization of the state and public services has been engaged. After an initial phase of market liberalization, Uzbekistan is moving into a more complex phase of reforms of land, labor, capital markets, and state-owned enterprises, but also health and social services. The most significant medium-term challenge will be ensuring reform inclusivity and transparency. To mitigate the economic, social, and health consequences of the pandemic, the Government has been taking anticrisis policy measures.

Uzbekistan is a lower middle-income economy (GNI per capita is 1 750 USD in 2020). It is an important producer of agricultural products (including cotton) and exporter of natural gas, oil uranium and gold. The informal sector is estimated at 45% of GDP, with almost as many people employed formally as in informal work. Unformal employment concerns above all agricultural sector (seasonal work) and services. The economy is also characterized by high inflation (14,7% in 2020). About 12% of the population live below national poverty line. HDI is 0.72 ranking Uzbekistan at the 106th position.

1.2. Sector Situation

Uzbekistan has been undergoing a major socio-economic transformation since 2016. Health is high on the political agenda and a key priority for the government, as reflected in a significant increase in the health budget in recent years.

As part of this transformation, the country has embarked on comprehensive and far-reaching reforms of its health system to achieve the goals of the "Vision for Health Development of the Republic of Uzbekistan 2019-2025". This includes a reform of financing, provision and modernization of health services, capacity building for health workers, digital transformation, better quality and access to health services and overall promotes the principles of Universal Health Coverage. Since July 1, 2021, a pilot project was conducted in Syr-Darya region, including more regions in 2023. In 2024 after the pilot was recognised as successful the reform was extended nationally.

Health coverage scheme includes an outpatient drug reimbursement component is a part of the reform. This system will include the issuance of an electronic prescription by a doctor, the receipt of medicines by the patient in a registered pharmacy and the subsequent compensation of the costs of issuing medicines at the expense of the Fund. The expected results from the introduction of the drug reimbursement system are an increase in financial protection of the population, management of chronic diseases, prevention of the number of ambulance calls and hospitalizations, as well as possible disability and mortality.

1.3. Role of Partner Institution in the Sector

The State Health Insurance Fund was established in 2020 in accordance with the decree of the President of the Republic of Uzbekistan. The SHIF is a state institution conducting non-profit activities. The main objectives of the Fund are to accumulate financial resources allocated to finance the state-guaranteed package of medical services and medicines, to carry out strategic procurement of medical services, to introduce a system of state health insurance (based on general taxation) in all regions of Uzbekistan. The Fund's supreme governing body is its Supervisory Board, which is chaired by the First Deputy State Counselor, and the members of the Supervisory Board are Deputy Ministers of Health and Finance, heads of the antimonopoly body and the national association of non-governmental non-profit organizations.

3. Methodology

3.1. General Methodology (of the Action)

The State Health Insurance Fund of Uzbekistan is the state institution in charge of mandatory health insurance in Uzbekistan.

Under the supervision of the Ministry of Health, the Fund is responsible for accumulating financial resources allocated to finance the state-guaranteed package of medical services and medicines, carrying out strategic procurement of medical services, introducing a system of state health insurance (based on general taxation) in all regions of Uzbekistan. The Fund's supreme governing body is its Supervisory Board, which is chaired by the First Deputy State Counselor, and the members of the Supervisory Board are Deputy Ministers of Health and Finance, heads of the antimonopoly body and the national association of non-governmental non-profit organizations.

After a pilot phase implemented in 2021-2024 in one region (and supported by SOCIEUX+ previous action 2022-01), a new health funding scheme is to be introduced throughout the country. In line with the Universal Health Coverage principles, the provision of a state-guaranteed package of medical services and medicines free of charge guarantees universal access for the entire population to the necessary medical care. Drug provision is part of the social protection of the population, in this regard, the Fund plans to introduce a system of reimbursement of medicines to the pharmacies that agree to provide medicines, at a given price, to the population.

Drug reimbursement was also an essential part of the pilot project, with 11 drugs provided free of charge through contracted pharmacies. The objective for the current phase (2025/2026) is to enlarge this list to 60 names, and generalize the distribution network up to 12 regions. Principles and procedures of the identification of the package of reimbursed drugs, for price setting, establishing relations with providers and overall reimbursement, including information flow should still be steered up or reviewed. The proposed action will support the Partner Institution in formalization of different components of the drug reimbursement programme through identification of a necessary regulations framework and then support to develop it. In particular, the in the first activity the experts have conducted a comparative analysis of the existent legal framework (from national legislation to secondary acts of the SHIF) and identified needs. They have subsequently proposed further activities to complete this action.

The proposed next 3 activities should focus on capacity building of relevant staff of SHIF (but not only) in view of the above depicted strategy for extension of the benefit package (geographically and in number of medicines) in the areas. In particular they will support the Partner Institution in the definition of a long term strategy and road map for the generalization of the medicines benefits package, definition of prices setting methodology and related procedures of reimbursement as well as setting up an anti fraud policies.

3.2. Planned Activities (Work Plan of the Action)

The following activities are currently planned for the action:

Activity 1 – Comparative analysis of the regulatory framework relative to drug reimbursement

- Activity 2 Development of a consistent roadmap for extension of a new pricing and reimbursement system to the entire country
- Activity 3 EU experience of the development of pricing and reimbursement mechanisms
- Activity 4 Setting up a system to combat fraud throughout the chain of dispensing medicines to the country's entire population

The present terms of reference cover the services expected for activities of the above work plan:

Activity #3.

3.3. Inclusion of cross-cutting issues

4. Activities description

4.1. Tasks

The principal expert will lead the on-site mission. He/she/they will be responsible for producing all activity deliverables (see Section **Error! Reference source not found.** below). He/she/they will be a lso responsible for preparing, coordinating, implementing and reporting the overall activity towards SOCIEUX+.

Further extensions of the medicines benefit package to be reimbursed to the pharmacies will need a new regulation and procedure for the pricing system to make it sustainable. The current pricing system in Uzbekistan was assessed as too costly. In fact, it consists of quarterly procurement tenders announced by the SHIF for each of the INN; and the five least expensive offers are retained. The difference between the least expensive and the fifth least expensive offer can be up to 5 times. The continuity of prices and of stocks is subject to quarterly chocks, and the SHIF cannot use a volume leverage to negotiate lower price with providers. Altogether, it makes the system expensive and unsustainable in the view of the coverage extension.

Although sufficient for the current volumes of the medicines reimbursed in the pilot project, it bears risks of being less efficient and even more costly in the future, therefore should be revised to accommodate the extension of the coverage. A new pricing mechanism is needed; it should take into consideration the main characteristics of the Uzbek public health financing system and drug reimbursement approach (tax-based; reimbursed directly to pharmacies while the beneficiary receives medicines free of charge), but also its challenges (digitalization in progress, budget limitations; extension of coverage, reluctancy of stakeholders; territorial disparities etc.).

Third activity will focus on refinement of the pricing and reimbursement mechanisms. Specific examples from the EU countries that share similar approach should be presented. The experts then will discuss with the Partner Institution to which extent these measures can be applied and adjusted in the context of Uzbekistan and finally provide recommendations to make the pricing and reimbursement mechanisms more sustainable.

The activity is planned to include an onsite mission of 10 working days to Tashkent, Uzbekistan, to ensure the efficiency of the peer-to-peer exchange.

The experts shall co-develop a proposal for peer-to-peer methodology and agenda together with the Partner institution, to be discussed and validated ahead of the mission. Without prejudice to the choice of tools by experts, methodological approaches may include peer-to-peer consultations, presentation of EU good practices, focus groups and questionnaires, setting and verification of hypothesis, collecting and processing quantitative data. Broader network of stakeholders can be involved into this activity, including the line ministry, patients' and professional organizations as well as social partners.

Task 1 - Preparation of the Mission

The Experts Team:

- Gains substantial knowledge of the local context; reviews any relevant background document provided by the SOCIEUX+ Team and/or the Partner institution (PI).
- Establishes in close consultation with the PI the mission's methodology and agenda (TMT for training – and MeN); then submits them for approval by the SOCIEUX+ Team.
- Participates in a pre-departure briefing with the SOCIEUX+ Team (approximately one week before the mission).

Task 2 - Implementation of the Mission

The Experts Team:

- Reviews and finalises the mission agenda and the list of stakeholders to be consulted with the PI upon arrival; any changes to the MeN shall be communicated to the SOCIEUX+ Team in a timely manner.
- Organises, as necessary, a brief presentation of the mission's objetives and methodology for the PI and relevant stakeholders.
- Provides a briefing on the background of the request and mission's objectives to the EU Delegation, if applicable.
- Conducts consultations with the PI's executives and staff, as well as relevant stakeholders, including the EU Delegation, as per the agenda.
- Compiles the initial findings and main conclusions emerging from the peer-to-peer technical exchange in a brief presentation that will be used for the final consultation and on-site debriefing.
- Channels any material that can be useful to inform the public about the activity (pictures, interviews, brief notes or articles).
- Liaises with the SOCIEUX+ Team at every stage of the implementation regarding doubts about the eligibility of proposals raised by the PI, politically sensitive developments, or any other relevant issue that may require a formal position from SOCIEUX+.

Task 3 - Final Consultation and Debriefing.

The Experts Team:

- Presents the initial findings and main recommendations emerging from the peer-to-peer technical exchange to the PI, relevant stakeholders and the EU Delegation.
- Collects the feedback of the PI, relevant stakeholders and the EU Delegation for inclusion, as possible, in their final draft of the activity's final deliverables.

Task 4 - Finalisation and Submission of the Deliverables.

The Expert Team:

 Prepares the final deliverables for review and feedback by SOCIEUX+, the PI and eventually other stakeholders.

5. Reporting and submission of deliverables

5.1. Formats

7. Applications

7.1. Call for Experts

All calls for experts for SOCIEUX+ activities are published online on the SOCIEUX+ website. Interested experts should submit their application on the SOCIEUX+ online expert database: https://pmt.socieux.eu (currently available only in English). The application process is as follows:

- 1. If they have not already done so, experts must create a SOCIEUX+ account by clicking "Create an account" and providing a valid email address.
- 2. Login details for their account will be sent to experts by email, experts should create and submit their profile for review by¹:
 - a. Providing contact details
 - b. Providing information on the competencies, skills and working history of the expert. Experts are required to provide only limited information through fields marked with an asterisk. However, <u>experts are encouraged to complete in most detail the sections on skills and competencies</u> as the SOCIEUX+ Team also regularly reviews profiles in the roster to identify and contact potential experts for future missions.
 - c. Uploading of a curriculum vitae, preferably in Europass format².
- 3. Once the SOCIEUX+ Team approves their profile, they can apply to any available calls for experts accessible under the tab "Call for Experts" and click on "Apply".

Applications are reviewed on a rolling basis, and positions may be filled as soon as suitable candidates are identified.

Experts can be identified and selected following a non-competitive procedure, which applies only in four specific circumstances:

- Experts to be mobilized from a 'preferred institution', i.e. the EU MS public entity indicated by the PI in the REF as the desired and most suitable learning model and source of expertise;
- Experts to be mobilized, on the request of the PI, from a 'supporting entity', i.e. a national
 or international development partner that supports the PI on the same or a similar area of
 work concerned by the request;
- Experts to be mobilized to accompany a study-visit by a PI's delegation to an EUMS, i.e. a public expert from one of the EUMS' hosting institution;

7.2. Selection of Experts

SOCIEUX+ primarily mobilises experts from the public administrations and mandated bodies of EU Member States, as well as practitioners working for social partners, including:

- Practitioners, civil servants and employees from publicly mandated bodies;
- Collaborators and employees of social partner institutions, such as trade unions and employer associations; and
- Academic and research institutions.
- Regional experts: they provide significant added value, since they belong to the institutions with which SOCIEUX has already worked in the region where the action will be carried out. In addition, regional experts/s can provide a contextualized perspective on the socio-political, economic and cultural realities of the region, which reinforces the relevance, feasibility and sustainability of proposals and outcomes.

Active public experts from collaborative institutions are given priority in the selection. Private consultants may also apply. Their application will be considered if an appropriate public expert cannot be identified. The mobilisation of experts currently employed with specialised international agencies is limited to activities and/or actions that are jointly implemented with that expert's agency of origin, indicated as the "Supporting Entity" in the Request.

Only short-listed applicants may be contacted. The selection process may include interviews by phone or other communication methods.

At SOCIEUX+ we value all experts as unique individuals, and we welcome the variety of experiences they bring to the Facility. As such, we have a strict non-discrimination policy. We believe everyone should be treated equally regardless of race, sex, gender identification, sexual orientation, national origin, native language, religion, age, disability, marital status, citizenship, genetic information, pregnancy, or any other characteristic protected by law. If you feel that you have been discriminated against, please let the SOCIEUX+ team know as soon as possible. Every complaint will be appropriately investigated.

7.3. Contracting of public experts

Public experts can be on active duty or retired. Retired employees from international specialised agencies or cooperation agencies can also be mobilised, regardless of whether their former employer collaborates with SOCIEUX+ on a specific action. Retired experts are considered public experts for all purposes, benefits, and financial compensation provided by SOCIEUX+.

Short-listed candidates may be required to provide their employer's contact details or proof of their ability to be directly contracted under their status as a civil servant or public employee.

Contracting Options:

<u>Active French Public Expert</u> (Contracted by Expertise France)

Engagement letter (+ Cumulation of Activities form signed by the hierarchical superior)

Active Spanish Public Expert

Spanish public servants will be contracted by FIIAPP according to its internal rules.

- <u>UE Public Expert</u> (including French and Spanish retired or private experts)
 - > Service contract with expert (+ Authorisation document from employer indicating the dates of the activity + a tax identification number (TIN) to be able to issue an invoice; or

- Umbrella company: experts who do not have a tax identification number allowing them to invoice for services in their country, but they are authorised to sign temporary employment contracts under local legislation; or
- > Service contract with institution: experts without a TIN and unable to sign an employment contract under local legislation.
- <u>Regional expert</u>: Depending on local legislation and the preferences of the expert's institution, the contract will be signed either directly with the expert or with the institution to which he/she belongs.

7.4. Financial compensations

Contracted officials or active-duty or retired employees are entitled to standard fixed allowances of <u>350 euros per working day worked</u>. The fees of private consultants are negotiated according to their number of years of relevant expertise and the standard scale of SOCIEUX+.

Retired experts are treated as public employees for all intents, purposes, benefits and financial compensation provided by SOCIEUX+.

National regulations on remuneration and compensation of public employees and civil servants apply and may limit the payment of allowances by SOCIEUX+. Compliance and verification are the responsibility of individual experts and their institutions of origin. The payment of income or other taxes is the sole responsibility of the mobilised experts and/or their organisations.

7.5. Travel costs

All travel expenses for the mobilised experts (public, private or international institutions) are covered by SOCIEUX in accordance with the <u>Guide for Experts and Collaborative institutions</u> (version as of the date of the contract signature), which provides detailed information on contracting with SOCIEUX+.

8. Communication & Visibility

SOCIEUX+ may use its communication channels, such as its website, newsletter and other media to share information on the implementation and results of the activities. To this end, contributions from mobilised experts are envisaged.

Small contributions for communication and visibility purposes, such as photographs, short texts and interviews, may be requested. Before and after the mission, short briefings may be organised with the SOCIEUX+ Communication Officer. These briefings will provide an opportunity to identify communication opportunities and strategies.

The correct use of SOCIEUX+ templates and visibility elements will be ensured in accordance with EU visibility guidelines.

For specific activities and events and under certain circumstances, visibility products such as brochures, folders, USB sticks, notebooks and other products may be made available to experts for face-to-face distribution.

9. Code of conduct

Experts mobilised by SOCIEUX+ will provide technical assistance from the preparatory stages of each activity through the delivery of products. The SOCIEUX+ Team will support experts in fulfilling their assignments by assisting and advising on the preparation of background materials before meetings. The SOCIEUX+ Team will also collect feedback from partner institutions and relevant stakeholders to ensure that mission reports and recommendations are delivered to national authorities, EU Delegations in partner countries, and the European Commission.

Experts mobilized do not represent SOCIEUX+ or the EU. Their technical opinions and recommendations are their own and do not reflect the official stance of SOCIEUX+ or the EU. They shall refrain from expressing negative opinions about the implementation of actions supported by SOCIEUX+ to third parties. However, they should be familiar with SOCIEUX+'s objectives and operations and promote its services to the best of their knowledge, whenever possible and feasible.

Experts shall perform their duties in the partner country in a manner that fully respects local institutions, policies, and cultural norms. They shall adopt culturally sensitive behavior when interacting with their local counterparts.
