### SOCIEUX+ FACILITY

SOCIEUX+ EU Expertise on Social Protection, Labour and Employment is a technical cooperation facility set up to improve the capacities of partner countries to design and manage inclusive, effective, and sustainable labour and employment policies and social protection systems. Based on capacity development through peer-to-peer technical cooperation and

exchanges, SOCIEUX+ provides access to European experts drawn primarily from the public administrations of EU Member States, offering expertise tailored to the demands and needs of EU Partner Countries. In addition to in-person exchanges, SOCIEUX+ includes an e-learning platform for online capacity development of partner institutions. SOCIEUX+ is results-oriented and demand-driven, responding to the requests of public institutions and social partners **in 160 EU Partner Countries and territories**.

### SCOPE OF WORK

Interventions are focused on peer-to-peer exchanges in all dimensions of social protection, labour and employment services, including but not limited to:

<p><b>Social insurance:</b> Old age benefits, invalid and survivor pensions; health insurance; occupational accidents and diseases; unemployment benefits; and maternity, family and household benefits.</p>	<p><b>Social assistance:</b> Guaranteed income schemes; poverty-targeted benefits; access basic and other social services; social security for informal workers; child protection and disability-inclusive social protection; disability assessment; etc.</p>	<p><b>Labour:</b> Labour law; occupational safety and health; working conditions; institutional reforms and practices; active labour market policies; formalisation of informal employment; eradication of child labour; decent work; due diligence; social relationships; and social dialogue.</p>	<p><b>Employment:</b> Public employment services; entrepreneurship services; jobs creation; policies and services design; vocational guidance and training; matching labour demand and labour supply; green jobs promotion; employability of vulnerable groups; youth employment; inclusive employment; and, soft skills.</p>
