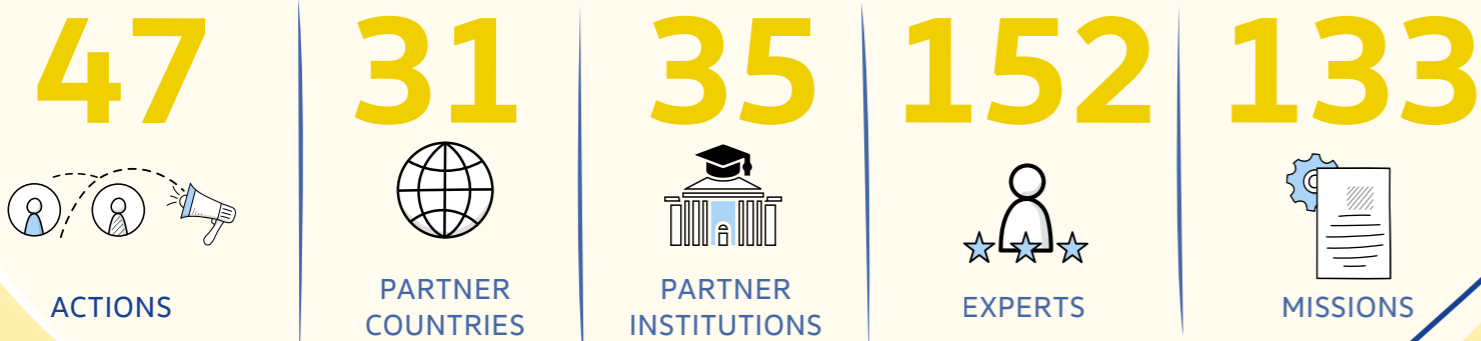


## Peer-to-peer technical cooperation between July 2020 and July 2022

SOCIEUX+ Expertise on Social Protection, Labour and Employment is a technical cooperation facility set up to improve the capacities of partner countries to design and manage inclusive, effective and sustainable labour and employment policies and social protection systems. Between July 2020 and July 2022, the implementation figures are as follows:



### Mid-Term Evaluation of SOCIEUX+: Key Findings

#### Relevance

- 84% of experts and 100% of partner institutions consider that the Facility have responded adequately to the needs of the partner countries.
- Most experts (73%) believe that the institutional demands on which they have worked were a priority for the country.
- The increased involvement of the European Union Delegations (EUDs) in the assessment of the Actions' relevance improved the adequacy of requests with the country's priorities.

#### Effectiveness

- SOCIEUX+ contributes to increasing the capacities to extend access to Employment and Social Protection to the vulnerable population.
- 85% of partner institutions confirms that there is an increase in the awareness of social protection and decent work thanks to the SOCIEUX+ actions.
- 70% of partner countries' implementing bodies responsible for Employment, Labour and Social Protection confirm that have improved their capacities in terms of: design better strategies, reform policies or programmes, and extend access to services to vulnerable populations.

#### Efficiency

- The technical cooperation mobilized by SOCIEUX+ is highly cost-efficient when comparing its actual cost, and its value for money, to market prices. The deliverables are of high quality and, generally, very much appreciated by the partner institutions (70% of cases are considered as excellent and 30% as good). The deliverables are produced by experts with public expertise.
- SOCIEUX+ is perceived as efficient, effective, and well-valued by partner institutions and EU Delegations.

#### EU Added Value

- The exchanges of experiences and peer-to-peer support add value to partner countries' policies and other donors' interventions.
- The participation of European public entities and experts builds on European principles including in relation to human rights.

#### Cross-cutting issues

- Various Actions directly address human rights as well as social & economic inclusion of vulnerable groups, and Persons with Disabilities.

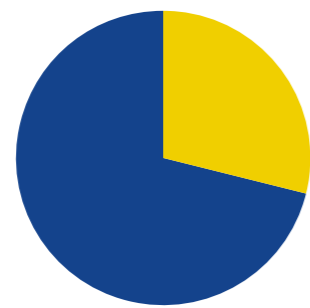

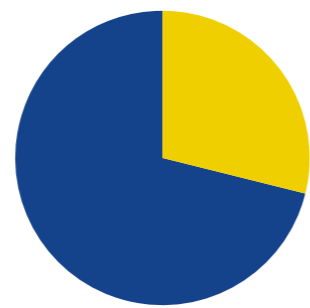

Do you think that the peer-to-peer (P2P) learning approach results in greater impact and sustainability of the facility actions?



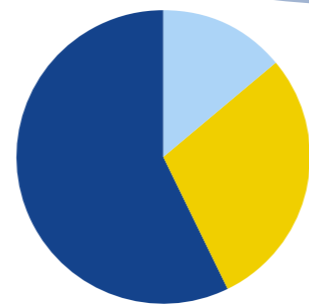

How would you rate the support provided by **SOCIEUX+** to your institution?

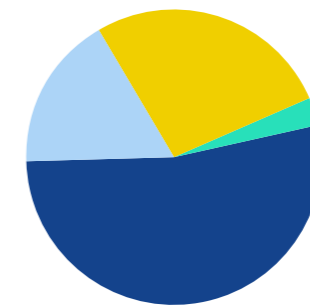

What is your overall assessment of **SOCIEUX+**'s contribution to improving social protection and employment?

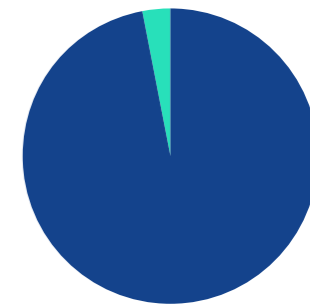
